## CORPORATE PROFILE

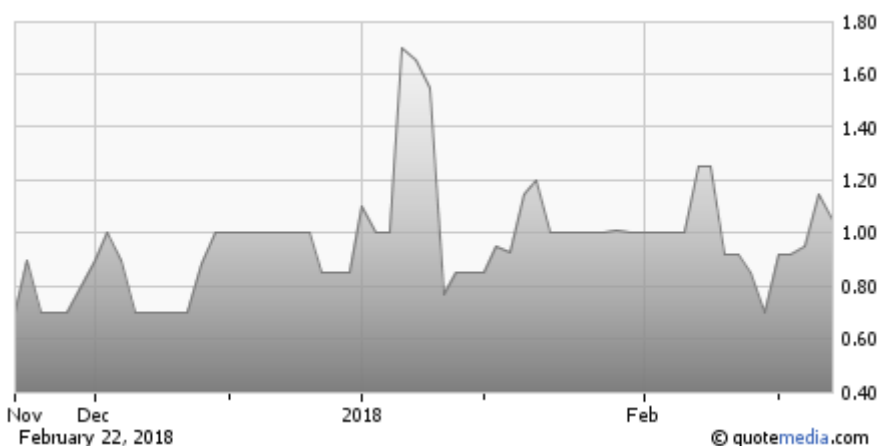
